If no such representations or objections are made or if any made are withdrawn North East Derbyshire District Council may confirm the Order as an unopposed Order. If the Order is sent to the Secretary of State for the Environment, Transport and the Regions for confirmation any representations and objections which have not been withdrawn will be sent with the Order.

PUBLIC PATH STOPPING UP ORDER 1 of 2023**

This Order is made on 30TH day of JANUARY 2023 by the North East Derbyshire District Council ("The Council") under Section 257 of the Town and Country Planning Act 1990 ("the 1990 Act") because it is satisfied that it is necessary to stop up the footpath to which this Order relates in order to enable development to be carried out in accordance with planning permission conditionally approved under Part III of the Town and Country Planning Act 1990 namely "22/00806/FL, Application for the Change of use of former Public house (Sui Generis) to single dwellinghouse (C3) (Conservation Area/Affecting a Public Right of Way) Butchers Arms Main Road Marsh Lane Sheffield S21 5RH", conditionally approved by North East Derbyshire District Council on 21/10/22.

BY THIS ORDER:

1. The public footpath situate over the land to the north of Butchers Arms, Main Road, Marsh Lane, in the Parish of Eckington and shown by a bold black line on the attached plan and described in Part 1 of the Schedule to this Order ("the Schedule"), shall be stopped up as provided below.
2. The Stopping Up of the footpath shall have effect on the confirmation of this Order.
3. Where immediately before the date on which the footpath is Stopped Up there is apparatus under, in, on, over, along or across it belonging to statutory undertakers for the purpose of their undertaking, the undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same rights in respect of the apparatus as they then had.



The whole width of that part of Eckington Public Footpath No 52 commencing at Point A (Ordnance Survey Grid Reference ("GR") SK 40601 79194) and proceeding in a westerly, then generally west north westerly direction to Point B (GR SK 40543 79202), for a distance of approximately 61 metres.

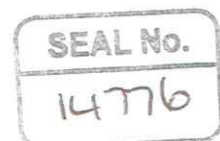


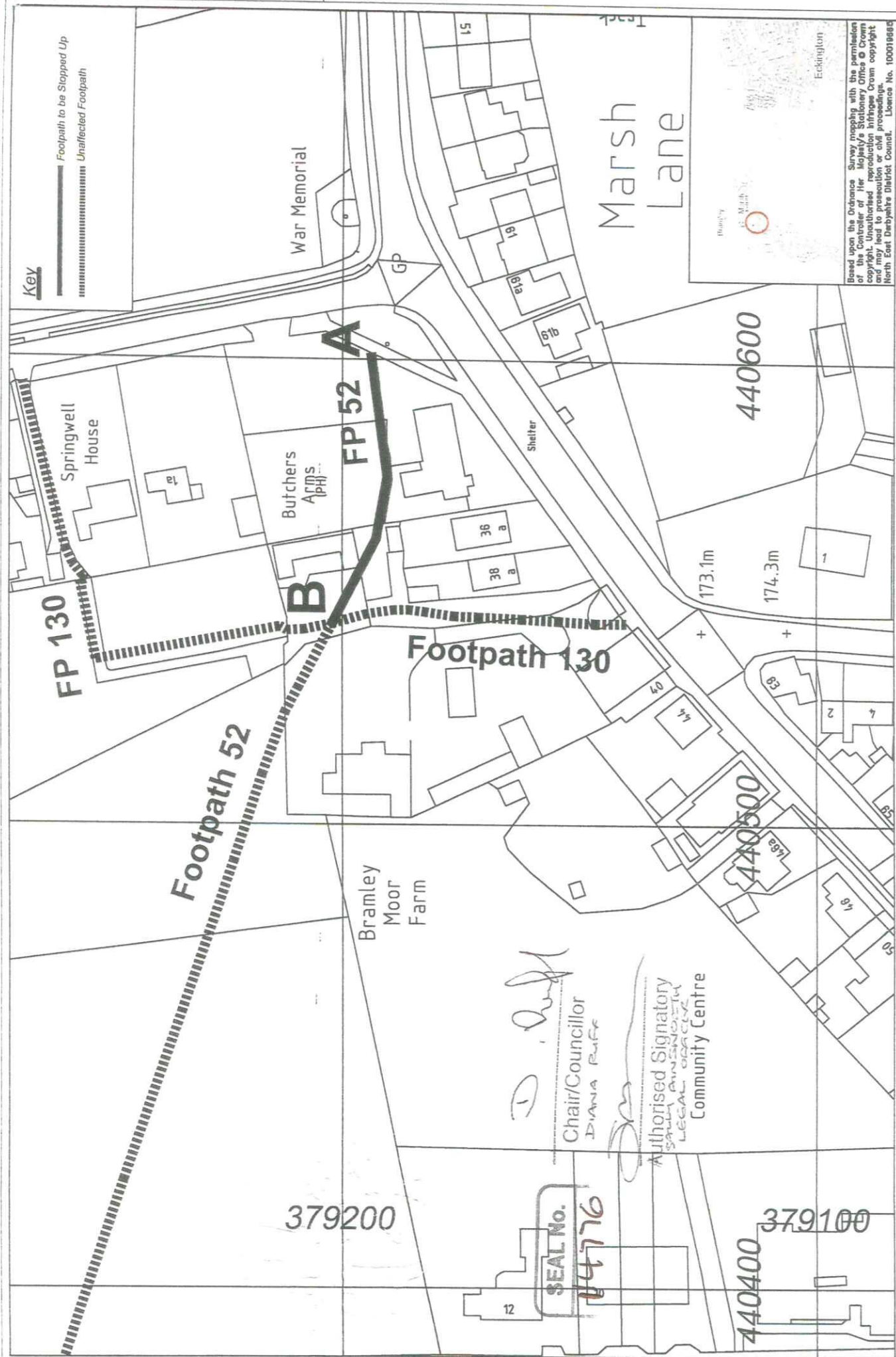
